Exhibition Instructions

1. Exhibition is open to all artists who have never been in a juried art show. (Student shows are not considered juried shows)
2. Artists of high school age through adult are invited to participate.
3. Limit one entry per person. First 100 entries accepted.
4. Enter NCA's Aspiring Artist Debut by hand-delivering one art work Saturday January 20, 2018 11AM - 3 PM to the Sacramento Fine Arts Center, Inc., 5330 B Gibbons Drive, Carmichael, CA 95608.
5. All artwork, except sculpture, MUST be framed and wired for hanging.
 - a. Only braided wire or strong plastic covered wire is acceptable for hanging. Tape ends of wire.
 - b. Artwork with protruding nails, staples or saw-toothed hangers will not be accepted.
 - c. Pastels must be under glass or Plexiglas.
 - d. Glass may not exceed 28x36 inches (or a maximum of 1015 sq. in.). Use Plexiglas instead.
 - e. Any work deemed unacceptable for any reason will not be shown.
6. Exhibited work must remain for the duration of the show.
7. Care will be taken when handling your work, however, neither NCA nor SFAC will be responsible for any damage incurred during the transportation, handling or exhibition of your work. Insurance is the responsibility of each submitting artist.
8. The Sacramento Fine Arts Center, Inc. will handle all sales from the exhibition and retain a 30% commission from each sale.
9. Artwork **must** be **picked up Sunday February 18, 2018, 5 PM** or the following week during regular gallery hours, Tuesday 11 AM to 7 PM & Wed. thru Fri., 11 AM to 3 PM, Sat and Sun. 11 AM to 5 PM. Please bring your artwork receipt (below) for verification.
 - a. All unclaimed artwork will be charged a storage fee of \$5.00 per day.
 - b. After 30 days, it will become property of SFAC.
