SPECIFICATIONS: Original art, not previously shown in a juried show at SFAC, and created within the last two (2) years. Open to all media. No copies, commercially-produced prints (including gicleés), or class/workshop art may be entered.

SIZE: Maximum framed size not to exceed 48" x 60". Glass may not exceed 28" x 36". Minimum framed size 9" x 12". Please use plexiglass on larger works. Glass must have rigid frames. ALL paintings must be dry and signed. ALL entries must be wired, and wire ends must be wrapped with tape or covered with tubing. Works must not contain saw-toothed hangers, staples, or protruding nails.

**NOTIFICATION:** A list of accepted entries will be posted on the NCA norcalarts.cloud and SFAC SacFineArts.org. websites. Please check for errors and contact show chair if any corrections are necessary. Accepted work must remain for the duration of the show. Work not selected must be picked up within three days of notification. A \$5 per day charge will be imposed for work left after one week from close of show. After one month, the art becomes property of SFAC.

SALES: SFAC receives a 30% commission on all sales. "NFS" work must be valued on the entry form.
